CYBER RISK EXPOSURE SCORECARD

RISK	SCORE	ACTION
1. Data Breach	High	Review data handling practices and implement security controls.
2. Ransomware	Medium	Implement backup and recovery procedures.
3. Business Email Compromise	Low	Implement email security filters and employee training.
4. Denial of Service	Low	Implement network security and incident response plan.
5. Social Engineering	Low	Implement security awareness training and phishing simulations.
6. Insider Threats	Low	Implement access controls and employee monitoring.
7. Third-Party Risk	Low	Implement vendor risk management and contractual requirements.
8. Regulatory Compliance	Low	Implement data privacy and security policies.
9. Intellectual Property	Low	Implement IP protection and security measures.
10. System Availability	Low	Implement disaster recovery and business continuity plans.
